REMINDER

For your vote to count, you must:

- 1) Vote your ballot and place it in the inner envelope with the attached certificate.
- 2) Seal the envelope. Complete and sign certificate.
- 3) Place the certificate envelope into the larger pre-paid envelope addressed to the Board of Elections and seal that envelope.
- 4) If another person will be mailing your ballot or bringing it to the Board of Elections, MAKE CERTAIN THAT PERSON COMPLETES THE "BEARER PORTION" ON THE ENVELOPE ADDRESSED TO THE BOARD OF ELECTIONS BEFORE THE BALLOT IS TAKEN FROM YOU. NO PERSON WHO IS A CANDIDATE IN THE ELECTION FOR WHICH THE VOTER REQUESTS THIS BALLOT IS PERMITTED TO SERVE AS A BEARER. NO PERSON IS PERMITTED TO SERVE AS BEARER FOR MORE THAN THREE QUALIFIED VOTERS IN AN ELECTION.
- 5) If returning your Mail-In Ballot in person it must be received by the County Board of Elections before the close of polls on Election Day.
- 6) If returning your Mail-In Ballot by mail, it must be postmarked no later than Election Day and received by the County Board of Elections no later than 48 hours after the election.

RECORDATORIO

Para que su voto sea válido, usted debe:

- 1) Marcar su preferencia en el voto y colocarlo dentro del sobre interior con el certificado adjunto.
- 2) Sellar el sobre. Completar y firmar el certificado.
- 3) Colocar el sobre certificado dentro del sobre más grande prepagado dirigido a la junta de elecciones y sellarlo.
- 4) Si es otra persona la que envía su voto por correo o lo lleva a la Junta de elecciones, ASEGÚRESE DE QUE DICHA PERSONA COMPLETE LA "SECCIÓN DEL PORTADOR" EN EL SOBRE DIRIGIDO A LA JUNTA DE ELECCIONES ANTES DE ENTREGARLE EL VOTO. NINGUNA PERSONA QUE SEA CANDIDATO EN LA ELECCIÓN PARA LA CUAL EL ELECTOR ESTÁ SOLICITANDO ESTE VOTO ESTÁ AUTORIZADA PARA SERVIR DE PORTADOR. - 5) Si regresa su boleta por correo en persona, debe ser recibida por la Junta de elecciones del Condado antes del cierre de las urnas de votación el día de las elecciones.
- 6) Si regresa su boleta por correo por el correo, debe tener estampilla y debe tardar el día de las elecciones y recibida por la Junta de elecciones del Condado a más tardar 48 horas después de la elección.
